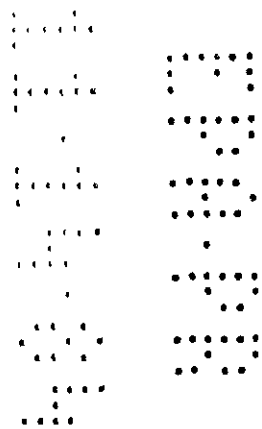

PREPARATION

All cutting, glueing, sanding and drilling should be done before applying ROTT-FYTER. Wood must be clean. Do not use over previously finished or stained wood without stripping off the old finish.

APPLICATION

1. Treating may be done with brush or roller, or by immersion.
2. Liberally apply ROTT-FYTER until puddles remain on surface.
3. Coat side and end grains with three or more consecutive coats to give full protection.
4. A minimum of two coats must be given to any wood that comes in contact with the soil to protect against wood destroying and staining fungi and dimensional change. Apply second coat before first coat is dry. For best results, soak wood intended to be used below ground for at least 15 minutes.
5. Any surface cut after first treatment should be re-treated.

SPREADING RATE

100-200 square feet of surface, depending on porosity of wood. By immersion, one gallon of ROTT-FYTER will treat about 10 to 15 cubic feet of wood, depending on porosity.

DRYING TIME

Allow 24 to 48 hours, longer if necessary because of poor drying conditions. Surfaces must be thoroughly dry before glazing, or applying paint, stain, varnish, or other finish.

THINNING

No thinning is required.

CLEANUP

Use soap and water to remove wet ROTT-FYTER from surfaces, brushes and rollers. Mineral spirits may be used to remove dried product from glass and other non-porous surfaces. Wash contaminated clothing before re-use.

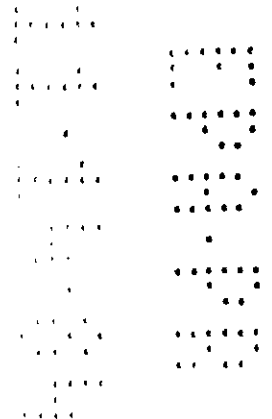

Wear rubber gloves when working with or handling lumber freshly treated with ROTT-FYTER.
