DIRECTIONS FOR USE

1. For best results dust liberally over entire body.
2. Be sure that the powder is applied on feet, paws and between toes.
3. Do not use on kittens or nursing puppies under four weeks of age. Do not use on pregnant dogs.
4. Care should be exercised to prevent powder from getting into the eyes and mouth.
5. Dust living quarters and bedding freely.
6. Repeat treatment, if necessary, should not be more often than once weekly.
7. If fleas and brown dog ticks are a problem in the home, baseboards, door entrances, crevices, and rug area should be dusted liberally weekly.

CAUTION: Avoid breathing of powder. Avoid contamination of feed and foodstuffs. Wash hands with soap and water after using. Harmful if swallowed or inhaled. May be absorbed through the skin. Avoid contact with the skin. Avoid contact with eyes. Do not use this product in commercial food areas of food handling establishments, restaurants, or other places where food is prepared or processed.

Notice to Physician: Carbaryl is a moderate, reversible, cholinesterase inhibitor. Atropine is antidotal.

STORAGE AND DISPOSAL
