Flea & Tick Collar for Dogs  
EPA Registration No. 4691-126  
Flea & Tick Collar for Cats  
EPA Registration No. 4691-127  
Your Submission Dated May 17, 1995

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling:

1. Add the following statement to the rear or side panel in bold, all caps:  
  
"READ ENTIRE LABEL BEFORE EACH USE. USE ONLY ON CATS (for cat collar) and USE ONLY ON DOGS ( for dog collar)."
2. Replace "Do not use on sick or convalescing cats/dogs" with "Consult a veterinarian before using this product on sick, debilitated, aged, pregnant, nursing or medicated animals."
3. Add the following precaution: "Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur remove collar and bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately."

Submit two copies of each final printed labeling before you release the products for shipment. A stamped copy of the labeling is enclosed for your records.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Place Flea Collar around dog's neck, adjust for proper fit and snap in place. The collar must be worn loosely and in addition to the regular collar. If collar is worn too tightly, it may produce neck irritation. Cut off and dispose of the excess length. Flea kill begins at once and will continue for 3 months while the collar is worn. Ticks are harder to kill but those on the neck area will soon be killed and easily removed. Collar will continue to kill ticks for 8 weeks. For continuous protection, replace collar every 3 months. Flea Collar can be worn with regular collar. Remove collar when washing dog - replace when dry.
