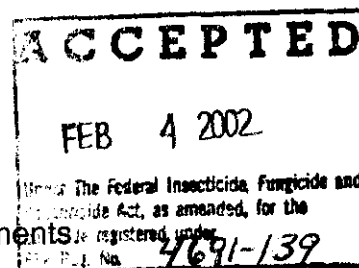

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with eyes, skin, or clothing. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals. Wash thoroughly with soap and water after handling.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

To treat pets for ticks and fleas, add the contents of one sachet to 1 gallon of water and mix thoroughly. Sponge the solution on pet until skin is wet. Apply in the ears and between the toes to insure complete tick control. Allow solution to dry on the pet for maximum residual effect. Do not use on dogs or cats under 12 weeks. Do not repeat treatment for one week. Consult a veterinarian before using this product on debilitated, aged, medicated, pregnant, or nursing animals. Do not store or reuse any remaining portion of the mixed solution.

STORAGE AND DISPOSAL

Pesticide Storage: Store in original container in a dry place away from children.

Pesticide Disposal: If empty, do not reuse this container. Place in trash or offer for recycling if available. If partly filled, call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
