**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For the most effective results, all carpeted surfaces should be thoroughly vacuumed and the entire dwelling should be treated. Use one can to treat 650 sq. ft. For use in homes, garages, attics, apartments, hotels, kennels and dog houses, and outdoor areas around the house where the pets lie or sleep. Also kills cockroaches, crickets, ticks, silverfish, spiders and ants.

**PREPARATION:** Cover exposed foods, dishes and food handling equipment. Open cabinets and closet doors to areas to be treated. Turn off fans and air conditioners. Extinguish all open flames except pilot light. Remove pets. Cover aquariums or fish bowls, or remove from area. Pet bedding is a primary hiding place for fleas and must be thoroughly treated or replaced for best results. Close outside doors and windows.

**APPLICATION:** Before spraying remove pets. To apply product, hold can upside down at arm's length directing spray towards area to be treated. Move arm in reverse sweeping motion by backing away from treated area. Immediately exit area. Do not occupy or allow pets to contact treated surface until the spray has completely dried. Before re-occupying, open all outside doors and windows, turn on air conditioner and fans and let treated area air for 30 minutes. Thoroughly clean all covered food processing areas before using. Retreatment may be required for the elimination of an established flea infestation.

**STORAGE & DISPOSAL**

**Storage:** Store in a cool area away from children.
