DIRECTIONS

Spray infested surfaces only until wet. **ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS:** Spray heavily into all cracks around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, etc. Spray other localized areas infested with these pests. Repeat treatment as required.

CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks or closets and infested areas of shelvings. Repeat as necessary.

FLIES, MOSQUITOES, WASPS, AND FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

FOOD HANDLING ESTABLISHMENTS

Food areas - application limited to crack and crevice treatment only.

Apply in small amounts directly into cracks and crevices using equipment capable of delivering a pinstream of insecticide in points between different elements of construction, between equipment and floor openings, leading to voids and hollow spaces in walls, equipment legs and bases where cockroaches, ants, spiders and silverfish hide. Aids in control of pantry pests (exposed stages of sawtooth grain beetle, flour beetle, rice weevil, cigarette beetle, drugstore beetle, and Indian meal moth) which come in contact with the treated areas.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contact of food or food processing surfaces.

APPLICATIONS OF THIS PRODUCT IN FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.

FLEAS, CHIGGERS, ANTS AND BROWN DOG TICKS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas where there is no vegetation, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

CAUTION

Avoid contact with skin. In case of skin contact wash with soap and water. Avoid breathing of spray mist. Do not use near open flame. Avoid contamination of feed and foodstuffs. Harmful if swallowed. Do not use on household pets.
