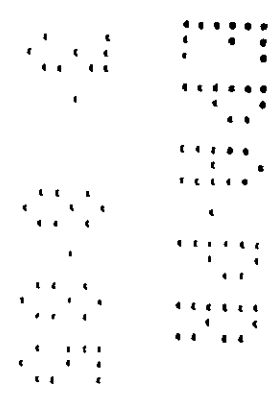

HAZARDS TO HUMANS AND DOMESTIC ANIMALS: CAUTION--

MAGIC CIRCLE INDUSTRIAL INSECTICIDE is a specially formulated space-type fly spray containing Pyrethrum and Piperonyl-Butoxide. This formula is a contact insecticide that has fast knock-down and high-killing power. It can be used in the home as well as in restaurants, food processing plants, milk rooms, and on dairy animals.

INDOOR SPRAY

FOR CONTROL OF FLIES, ADULT MOSQUITOES, GNATS, AND SMALL FLYING MOTHS in homes, food establishments, farm buildings, and warehouses: Close all windows and stop all ventilators. Pilot lights should be extinguished. Remove pets, birds, and cover fish aquariums before spraying. Allow only fine mist or "dry" fog to contact fabric or surfaces that might be affected by the oil base. Direct fine mist or fog upward toward the center of the room and around the sides until the area is filled with fog or mist particles. Keep area closed for 10 to 15 minutes. Clean up and destroy fallen insects.

CONTACT AND SPACE SPRAY--TO KILL COCKROACHES, SILVERFISH, EARWIGS, ANTS, AND SPIDERS IN SHELTERED SITUATIONS: Adjust spraying device to deliver a coarse wet spray. Apply as a contact spray into all cracks and crevices in woodwork, walls, floors, underneath sinks, behind pipes, and in all places where these insects shelter. Contact as many insects as possible. Do not allow spray to contact stored food. Then adjust sprayer to deliver aerosol size particles. Apply as a space spray at the rate of 1 to 2 fl. oz. per 1,000 cu. ft. of room space. Repeat dosage as necessary for control. Leave the room closed for 1 hour. Do not remain in treated area. Ventilate the area thoroughly before re-entry.

FOR SILVERFISH: Spray baseboards, windows, doorframes, bookcases, and storage areas, contacting as many insects as possible. Allow only fine mist or "dry" fog to contact fabric or surfaces that might be affected by the oil base.

FOR WASPS AND SPIDERS: Spray insects directly and apply heavy spray to nests and webs. The most effective wasp control is obtained by spraying after dark when all insects have returned to the nest.

FOR CARPET BEETLES: Clean all rugs, carpets, and fabrics to be treated. Spray both surfaces of carpets and floor space beneath evenly with a fine mist spray. Particular attention should be paid to cracks and crevices around the baseboards.

ANIMAL SPRAY FOR HORSES, DAIRY AND BEEF CATTLE, HOGS, AND SHEEP: For protection against Stableflies, Hornflies, and Houseflies attacking animals, spray the animal against the grain of the hair, directing a fine mist around the base of the horns, on the legs, and along the sides and belly and over the back. Do not spray udders. Apply just enough to wet the ends of the hair but not enough to wet the hide. One or two ounces of spray is sufficient to treat an adult cow. Apply once daily or as necessary.

FOR FLEAS: Spray floors, rugs, animal sleeping quarters, and other infested areas with a fine mist spray. Repeat as necessary. Change animal bedding after treatment.

FOR CLOTHES MOTHS: Spray inside surface of closets and other storage containers thoroughly, paying particular attention to cracks. Spray cleaned clothes and fabrics lightly, especially seams and folds. Repeat every two or three weeks, unless treated articles are packed in moth-tight containers.

STORAGE & DISPOSAL THROUGH 1 GALLON SIZE

Store this product in its original, closed container in a locked area, away from children and domestic animals. Do not reuse empty container. For disposal, securely wrap closed original container in several layers of newspaper and discard in trash. Do not contaminate water, feed, or food by storage or disposal.
