## STORAGE AND DISPOSAL

### STORAGE:

Keep container tightly sealed. Store in-doors in an upright position and in a cool dry place. If container is damaged, check for any leaks. If leaking, transfer contents into another suitable container. Avoid contamination with other chemicals. Spillage should be washed off with a 5% sodium hydroxide solution then rinsed with water. Avoid contact with skin.

### PESTICIDE DISPOSAL:

Pesticide, spray mixture or rinse water that cannot be used according to label-instructions must be disposed of according to applicable Federal, State, Province or local procedures. **DO NOT** contaminate water, food or feed by storage or disposal.

### CONTAINER DISPOSAL:
