The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. A stamped copy is enclosed for your records.

Revise your Confidential Statement of Formula (CSF) dated 5/2/91 so that the upper certified limit is greater than the lower certified limit for Ground Vegetable Matter. Refer to Title 40 of the Code of Federal Regulations, part 158.175 for further guidance. Do not refer to Reg. No. 4713-6 as the source of pyrethrins on your CSF (Column 12), since a product can not use its self as a source.

Modify your Environmental Hazards statement to read as follows:

"This pesticide is highly toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or public waters unless this product is specifically identified and addressed in an NPDES permit. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. For guidance, contact your local State Water Board of Regional Office of the EPA."


