DIRECTIONS FOR USE

AS AN ANIMAL SPRAY: To control horn flies, cattle lice, hog lice, ear tick, Lone Star tick, Gulf Coast tick, Winter tick, sarcoptic mange mite, psoroptic Scab Mite and Cattle Fever tick on beef cattle, horses and hogs, dilute one quart of Toxamal with 30 gallons of water and mix well to form a creamy emulsion. Spray animals with a strong spray to penetrate to the skin. Approximately two quarts of spray is required for a full grown horse or cow, and proportionally less for smaller animals. Repeat applications as necessary. Do not apply to young animals 6 months or less of age. Do not apply to dairy animals. Do not apply to meat animals within 30 days of slaughter.

To control sheep ticks, sheep lice, and goat lice on sheep and goats, dilute one quart of Toxamal with 50 gallons of water and spray animals thoroughly. Always stir well just before using. Repeat applications as necessary. Do not spray animals within 30 days of slaughter. Do not use on dairy goats.

AS AN ANIMAL DIP: For beef cattle, hogs, sheep and goats, use Toxamal in the dipping vatathe same dilutions given above for sprays (except for sheep ticks, sheep lice, and goat lice, one gallon may be diluted with as much as 500 gallons of water). Always stir well just before using. Toxamal is properly emulsified for the animals' protection. Methods used for determining the dipping vat concentration of toxaphane may also be used for Toxamal. Repeat applications as necessary. Do not dip livestock within 60 days of slaughter. Do not dip animals less than six months old. Do not treat dairy animals.

AS AN OILER COMPOUND: As an aid in reducing lice and to control horn flies, mosquitoes, and gnats on beef cattle, use one gallon of Toxamal to 15 gallons of oil. Place the oiler in areas so that animals will have free access to it, such as around loafing areas, feed lots and salt licks. Do not permit animals access to rubbing de-

vices within 30 days of slaughter. Do not allow dairy cattle access to oilers.

AS A PREMISE SPRAY: For residual insect control of flies, fleas, mosquitoes, roaches, ants and certain other insects dilute one gallon of Toxamal with 20 gallons of water and spray around barns, stables and sties. Treat manure piles and other breeding places thoroughly. Thoroughly wet all surfaces where flies and mosquitoes alight or crawl and all cracks and other places where animals sleep. Repeat applications as necessary. Do not use inside homes nor in dairy barns or in poultry houses.

WARNING: May be fatal if swallowed. Do not breathe spray mist. Do not get in eyes, or on skin or clothing. May be absorbed through skin. Wash thoroughly after using. Avoid contamination of feed and foodstuffs. Destroy or burn containers when empty. Never re-use. Stay out of smoke or fumes. Bury spillage; clean up area with strong lye solution.

Do not use on calves under 6 months of age. Do not apply on dairy animals or in dairy barns.

Toxic to fish and wild life. Do not contaminate streams, lakes or ponds with this spray or washings from the spray tank.
