

DIRECTIONS FOR USE

AS AN ANIMAL SPRAY: To control horn flies, cattle lice, hog lice, ear tick, Lone Star tick, Gulf Coast tick, Winter tick, sarcoptic Mange Mite, psoroptic Scab Mite and Cattle Fever tick on Horses, Beef Cattle, Sheep, Goats and Hogs, dilute one quart with 45 gallons of water and mix well to form a creamy emulsion. Spray animals with a strong spray to penetrate to the skin. Approximately two quarts of spray is required for a full grown horse or cow, and proportionally less for smaller animals. Repeat applications as necessary. Do not apply to young animals 6 months or less of age. Do not apply to dairy animals.

To control sheep ticks, sheep lice and goat lice, dilute one quart with 75 gallons of water and spray animals. Always stir well just before using. Repeat applications as necessary. Do not spray animals within 30 days of slaughter.

AS AN ANIMAL DIP: For Horses, Beef Cattle, Sheep, Goats and Hogs, use in the dipping vat at the same dilutions given above for sprays (except for sheep ticks, sheep lice, and goat lice, one gallon may be diluted with as much as 750 gallons of water). Always stir well just before using. High Strength Protex-Toxadane is properly emulsified for the animal's protection. Methods used for determining the dipping vat concentration of toxaphene may also be used for this product. Repeat applications as necessary. Do not dip livestock within 60 days of slaughter. Do not apply to young animals 6 months or less of age. Do not apply to dairy animals.

AS AN OILER COMPOUND: As an aid in reducing lice and to control horn flies, mosquitoes and gnats on Beef Cattle and Hogs, use one gallon to 22-1/2 gallons of oil. Place the oiler in areas so that the animals will have free access to it, such as around loafing areas, feed lots and salt licks. Do not permit animals access to rubbing devices within 30 days of slaughter. Do not apply to young animals 6 months or less of age. Do not apply to dairy animals.

AS A PREMISE SPRAY: For residual insect control of flies, fleas, mosquitoes, roaches, ants and many other insects, dilute one gallon with 30 gallons of water and spray around barns, stables and sties. Treat manure piles and other breeding places thoroughly. Thoroughly wet all surfaces where flies and mosquitoes alight or crawl, and all cracks and other places where roaches and ants hide. For fleas, thoroughly treat places where animals sleep. Repeat applications as necessary. Do not use in Poultry Houses, Dairy Barns or Milk Rooms. Do not use inside homes.

WARNING: May be fatal if swallowed. Do not breathe spray mist. Do not get into eyes, on skin or clothing. Wash thoroughly after using. Do not contaminate feed or food stuffs. In case of contact with eyes or skin, wash immediately and get medical attention for eyes. May be absorbed through the skin.

Avoid treating overheated or sick animals. Avoid treating animals in cold stormy weather. Do not apply this product to dairy animals. Do not apply in dairy barns, milk houses or poultry houses nor to pets or humans. This product cannot be used on food or forage to be fed to dairy animals or animals being finished for slaughter. Water animals before dipping.

This product is toxic to fish and wildlife. Keep out of any body of water. Apply this product only as specified on this label. Rinse equipment and containers and dispose of wastes by burying in non-crop land away from water supplies. Containers should be disposed of by punching holes in them and burying with wastes or by burning. (Keep out of smoke).
