

• DIRECTIONS FOR USE BACK PUMPING DEVICE FOR COWS

To control horn flies and adult ear gnats on Beef Cattle and Horses: Put Toxaphene Ready-Mixed Oiler compound in oiler without any dilution. Use one milking device to every 15-40 head of cattle. Retreat the cattle every 4-6 weeks.

To control lice on Sheep: Put Toxaphene Ready-Mixed Oiler compound in oiler without any dilution. Do not allow sheep access within 1 week of farrowing, etc., for at least 2 weeks thereafter.
