DIRECTIONS FOR USE

APPLY AS A SPRAY — Use a hand mast type or pressure sprayer. Two flowing coats of Penta 5 are usually sufficient to protect joists, unibers and other wood work from Lyctus Powder Pest Beetles and Wood Rotting Craganisms. Treat all structures which come in contact with the soil. Spray all ends and joints of wood for a distance of 3 to 4 feet as well as sections around chiraneys, cellar stairs, yent pipes and porches.

APPLY WITH A BRUSH — When applying with a brush make sure that the material penetrates the wood. Make a second application to insure proper treatment, Allow the material to tree-ly flow over the areas to be treated paying special attention to the lads and joints for a distance of 3 to 4 teet.

DIPPING OR SOAKING — To protect dry and well seasoned timbers, posts and other heavy wood members before construction or before placing wood in contact with the soil, dipeach wood member for 12 to 4s hours to give effective penetration of the wood. Fabricated products such as doors, windows, etc., should be dipped 3 to 30 minutes. All wood members should be free of back before receiving treatment.

WINTER GRASSES AND BROAD LEAVED ALEDS IN DORMANT BERMUDATURE: To control Chickweed, Hairy Chess Grass, Rescue Grass, Cheat, Annual Bluegrass, Plantains, June Grass and Little Barley Grass, add 1 qt. and 2 ounces of Penta 5 to 2-1/2 its. Of Kerosene. Spray this diffute mixture over 1000 sq. ft. of turf area to thoroughly over the undesirable weeds and grasses. Apply to the lawn only when the Bermuda Grasses are commant in the fall and winter after the tops have been killed or in early spring before the new growth starts. Do not increase dosage rates since injury may result to the perimanent grasses.

TERMITE CONTROL IN HOUSES — When termites are known to exist in foundation structures such as supporting pillars in steps and porches as well as in house sidings, and upper structures, the soil adjoining the woodor adpacent to termite runs should be treated. Since the Termite nest is in the soil the natural thing to eliminate them is to cut them off from the nest. Open a trench around the foundation or the adjacent wood structures 30 inches deep, but not below the top of the footing if this is more shallow. Treat the bottom of the trench with Penta 5 and then replace the soil in the trench and treat the soil. Apply at the rate of 1 gallon to 1 linear foot of the trench. Inspect treated areas frequently for reinfestations.
