

**GENERAL INFORMATION**

**6 lb. Toxaphene Oil Solution** is an oil soluble concentrate for preparing oil base sprays for the control of grasshoppers by airplane or ground application.

The Federal Food and Drug Administration has set official tolerances for certain pesticide residues. In order that residues on food and forage crops will not exceed established tolerances, use only at recommended rates, and do not apply closer to harvest than specified. Observe use limitations given on label for specific crops.

**DIRECTIONS FOR USE**

**SPRAYS:** For the control of grasshoppers in highway and power-line rights-of-way and roadsides by airplane application, apply 2 pts. per acre for nymphs and 2-2/3 pints per acre for adults. Dilute with kerosene or fuel oil to make 2 1/2-5 gallons of spray per acre. Make only one application per season.

**NOTE:** Do not allow dairy animals on treated areas. Do not graze meat animals on treated areas within 6 weeks of slaughter. Do not apply to forage to be sold commercially or shipped interstate.

**BAITS:** For a dry bait on highway and powerline rights of-way, roadsides, ditch banks, and fence rows, mix 1-1/3 pints in 1/2 gallon of kerosene or fuel oil, and apply in a fine spray to 100 pounds of coarse, dry bran. Thoroughly mix and apply bait at 5-10 pounds per acre with ground equipment. Keep away from livestock

It is usually more economical to control grasshoppers in the designated areas before they move onto crops of economic value.
