ZONE CONTROL

To prevent reoccurrence of fleas, a total management program is recommended. You should treat the areas where fleas live with the HOLIDAY 4-Step Program which consists of: Step 1- Shampoo/Dip the Pet; Step 2- Treat the Home and Yard; Step 3-Flea and Tick Collars on the Pet; Step 4- Maintenance Sprays and Powders.
