You should treat the areas where fleas live with the HOLIDAY® 4 -Step Program which consists of: Step 1 - Shampoo/Dip the Pet; Step 2 - Treat the Home and Yard; Step 3 - Flea and Tick Collars on the Pet; Step 4 - Maintenance Sprays and Powders. Ask your pet care professional for specific recommendations on how to best control fleas for the comfort and well being of your pet and family.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS WARNING

DO NOT USE FULL STRENGTH, MIX WITH WATER AS DIRECTED.

Flea dip concentrates may harm animals when used at greater strength than specified on the label.

May cause eye injury. Do not get in eyes, or on clothing. Wear eye protection when mixing concentrate with water. Applicators of flea and dip products are to use protective gloves to reduce the risk of dermal irritation or dermal sensitization. Harmful if swallowed. Wash thoroughly with soap and water after handling.

Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication.

Do not use on puppies or kittens under 12 weeks of age. Young animals should be towel dried immediately after treatment to prevent chilling. Do not repeat treatment for one week.

Sensitivities may occur after using ANY pesticide product for pets. Individual animals may exhibit one or more of the following symptoms: hypothermia, tremors, ataxia, excess salivation, agitation and vocalization followed by lethargic behavior, skin and eye irritation in varying degrees. If signs of

sensitivity occur bathe your pet with mild soap and rinse with large amounts eliminates unpleasant pet odor, leaving in its place a pleasant citrus fragrance. of water. If signs continue, consult a veterinarian immediately.

PHYSICAL OR CHEMICAL HAZARDS

Do not use or store near heat or open flame.

ENVIRONMENTAL HAZARDS

Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high-water mark. Do not contaminate water when disposing of equipment washwater or rinsate.

FIRST AID

If Swallowed: Call a physician or Poison Control Center. Give milk or water, but do not induce vomiting except under medical supervision because of aspiration hazard. Do not give anything by mouth to an unconscious person.

If on skin: Wash off with soap and water. Get medical attention if irritation develops.

If in eyes: Flush with plenty of water. Get medical attention May be used in conjunction with organophosphate and carbamate based insecticides. Does not inhibit acetylcholinesterase activity.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

TO KILL FLEAS AND TICKS ON dogs, cats, puppies, and kittens. Do not use on puppies or kittens under 12 weeks of age.

Mix 1 1/2 oz. (3 tao espoons) to 1 gallon of water or 2 teaspoons to 1 quart of water. DO NOT USE FULL STRENGTH, DILUTE AS DIRECTED.

Mix well. Wet animal with water first. Sponge or sprinkle on animal until cost is thoroughly wet. Rub well into fur, between toes and on ears. Avoid ere, scrotal, and anal areas. For best results do not rinse but allow to dry naturally. Citrus ingredient conditions the coat, leaving it shiny and soft, and
