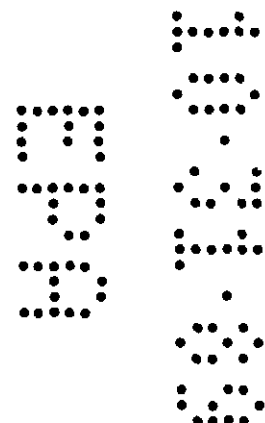

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

WARNING: Causes substantial but temporary eye injury. Do not get in eyes. Avoid contact with skin or clothing. Harmful if swallowed or absorbed through skin. Wash thoroughly with soap and water after handling. While spraying on animal, do not get in animal's eyes. Do not use on puppies or kittens under 4 weeks of age. Use with care on nursing animals. Do not use on irritated skin. Some individuals and pets may be sensitive to this product. Discontinue use if irritation develops.

May be used in conjunction with organophosphates and carbamate based insecticides. Does not inhibit acetylcholinesterase activity.

PHYSICAL OR CHEMICAL HAZARDS

Flammable. Keep away from heat and open flame.

STATEMENT OF PRACTICAL TREATMENT

- If swallowed: call a physician or Poison Control Center. Give one or two glasses of water and induce vomiting by touching back of throat with finger. Never give anything by mouth to an unconscious person. Contains ethyl alcohol.
- If on skin: remove contaminated clothing and wash before reuse. Wash affected areas thoroughly.
- If in eyes: flush eyes with plenty of water. Get medical attention.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labelling.

- 1) Remove cap and insert sprayer.
- 2) Use spray in well ventilated areas.
- 3) Hold pump spray 4-6 inches from animal and direct spray into hair until damp to touch, but avoid run-off. To insure all insects are directly contacted, spray must penetrate to skin. Rub spray down into hair. Be sure to include legs and paws. To avoid irritation, do not spray around eyes, on face or genital area.
- 4) Treat the pet's bedding as it is a primary hiding place for fleas. If heavily infested, replace old pet bedding and spray fresh bedding.

STORAGE AND DISPOSAL

Storage: Do not contaminate food or water by storage.

Disposal: Do not reuse container. Securely wrap empty containers in several layers of newspaper and discard with trash.
