Wet dog or cat with warm water and apply small amount of shampoo along the back of the animal. Work into the coat well, starting at head and working back. Be sure to include feet and legs. When lather is of desired consistency, continue to work into coat for 5 minutes to kill fleas. Rinse thoroughly with warm water. May be diluted up to 1:3 (1 part shampoo with 3 parts water) as desired.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool, dry area inaccessible to children and pets.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
