Use Restrictions: Do not use on puppies or kittens under 12 weeks of age. While washing pets, avoid getting shampoo in animal's eyes.



Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication.

Wet dog or cat with warm water and apply small amount of shampoo along the back of the animal. Wear gloves and work into the coat well, starting and head and working back. Note: Contact with pesticides by applicators is not advisable; therefore, instead of rubbing the shampoo into the fur of animals with hands, use of a brush is recommended. Be sure to include feet and legs. When lather is of desired consistency, continue to work into coat for 5 minutes to kill fleas. Rinse thoroughly with warm water. May be diluted up to 1:3 (1 part shampoo with 3 parts water) as desired. Do not reapply product for one week.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool, dry area inaccessible to children and pets.
