### SHAKE WELL BEFORE USING

**DOGS AND CATS:** Dilute at the rate of 2 ounces in 1 gallon of water. Mix only amount needed in an 8 hour period. For control of fleas, ticks, mites and lice, sponge or pour solution on entire animal, thoroughly wetting the skin. Rub well into fur, on ears, legs and paws. For best results, do not rinse, but allow to dry naturally. Towel dry all young animals immediately after dipping to prevent chilling. Wash hands with soap and water after using. Avoid contact with pet's face, eyes and genitalia. Do not treat kittens or puppies less than 8 weeks of age. Do not use on old, sick or debilitated animals.

Repeat treatment in 3 days if necessary.

### STORAGE AND DISPOSAL

**STORAGE:** Do not store below 32° F. If frozen, thaw and shake well. Store in a cool dark area.

**DISPOSAL:** Do not reuse empty container. Rinse thoroughly, wrap container in several layers of newspaper and discard in trash.
