# KENNELS OR PET SLEEPING OUARTERS:

Apply thoroughly to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind base'boards, window and door sills, and localized areas of floor and floor covering where fleas, ticks and lice may be present. Old pet bedding should be removed and replaced with fresh bedding after treatment of pet areas. Do not spray surfaces where spotting, staining or discoloration would be objectionable.

### HOUSEHOLD TREATMENT:

Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture, and in closets. Seal vacuum bag and dispose of in trash outdoors. Mop hard surface floors. Using a smooth back-and forth motion, spray all floors and aforementioned areas thoroughly. Provide a good even treatment but do not soak the areas that you treat. Do not reapply product for two weeks.
