DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Wearing rubber gloves while applying product is recommended. For best results, wash pet with an insecticidal shampoo prior to application of Linalool Mousse. Rinse shampoo thoroughly from hair coat and towel dry to remove excess water.

Avoiding the pet's eyes and nose, hold the Linalool Mousse container upside down and dispense directly onto the pet by depressing the

dispensing valve to deliver the foam. **Linalool Mousse** can be dispensed into the hand and applied to the pet.

Apply Linalool Mousse to the pet's haircoat and massage into the hair until the foam disappears. Apply enough Linalool Mousse to thoroughly moisten, but not soak, the entire haircoat including legs, feet and tall. The amount of Linalool Mousse needed will vary according to pet size and thickness of haircoat.

Allow your pet to dry. Do not use a towel to dry your pet, this will remove some of the **Linalool Mousse**, thereby reducing the residual activity. If needed, use a blow dryer set on low to medium heat to shorten the drying time.

After application, wash hands thoroughly with soap and water.

Do not repeat treatment for 30 days. Do not treat dogs under 6 months of age with this product. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication.

Storage and Disposal

Storage: Do not store below 32° F. Avoid freezing to prevent container damage. If exposed to temperatures below 32° F, warm to room temperature and shake well before using.

Pesticide Disposal: Securely wrap original container in several layers of newspapers and discard in trash.

Container Disposal: Replace cap and discard container in trash. Do not incinerate or puncture.
