PERMETHRIN PLUS FOGGER contains Nylar, an insect growth regulator that inhibits the ability of the flea to reproduce thereby eliminating the flea population. Immature fleas are prevented from developing into adults and the life cycle of the flea is effectively broken. Permethrin Plus should be applied every 7 months to provide continuous protection against flea infestation.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product will kill fleas (adults and pre-adult), roaches, houseflies, black carpet beetles, ticks, ants. spiders, flying moths, mosquitos, silverfish, sawtoothed grain beetle, rice beetles, pill bugs, crickets, confused flour beetles, wasps, hornets, and palmetto bugs. Cover or remove exposed foods, dishes and food handling equipment. All food processing surfaces should be covered immediately prior to treatment or thoroughly cleaned after treatment. Close doors and windows. Open cabinets and interior doors within the treatment area. Shut off fans and air conditioners. Put out open flames except pilot light. Remove pets. Cover or remove fish tanks and bowls

Fogger should be placed on floor in the middle of the room. Place newspaper under the container to prevent marring surfaces. Use one container for each 6,000 cubic feet of unobstructed area (approximately 30'x 20'x 10' room). Use additional units for remote rooms or where free flow of mist is not assured. Do not use this unit in a cabinet or under a counter or table. Do not use this unit in an area less than 100 cubic feet. To start fogging, press down the actuator tab to locked position. Keep at arm's length when activating. Point top of can away from face and eyes. Set in upright position and leave building at once. Leave undisturbed for 2 hours. Open doors and windows and allow to air for 1 hour.
