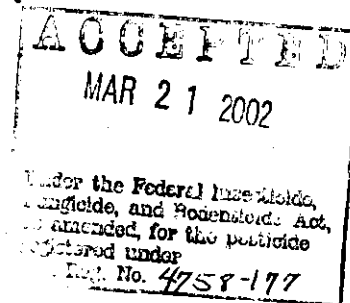

STATEMENT OF PRACTICAL TREATMENT

Remove pets, birds and cover fish aquariums before spraying. Do not allow children or pets to contact surface until spray has dried.

HOUSEHOLD TREATMENT: Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose of in trash outdoors. Mop hard surface floors. Using a smooth back and forth motion, spray all floors and other aforementioned areas thoroughly. Provide a good even treatment but do not soak the areas that you treat. If fleas reappear, you should either repeat treatment or allow the product's residual effect to kill the newly emerged fleas.

KENNELS OR PET SLEEPING QUARTERS: Apply thoroughly to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door sills, and localized areas of floor and floor covering where fleas, ticks and lice may be present. Old pet bedding should be removed and replaced with fresh bedding after treatment of pet areas. Do not spray surfaces where spotting, staining, or discoloration would be objectionable.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Do not use or store near heat or open flame. Store in a dry area inaccessible to children.

Disposal: Do not reuse empty bottle. Rinse thoroughly before discarding in trash.
