AFTER WORK, take off all work clothes and shoes. Shower, using soap and water. Wear only clean clothes when leaving job. Do not wear contaminated clothing. Vash protective clothing and protective equipment with soap and water after each lise. Respirator should be cleaned and filter replaced according to instructions included with respirator.

POISON SIGNS (Symptoms)

Parathion is a very dangerous poison. It rapidly enters the body on contact with all skin surfaces and eyes. C'othing wet with material must be removed immediately. Exposed persons must receive prompt medical treatment or they may die.

Some of the signs and symptoms of poisoning are: Headaches, nausea, vomiting, cramps, weakness, blurred vision, pin-point pupils, tightness in chest, labored breathing, nervousness, sweating, watering of eyes, drooling or frothing of mouth and nose, muscle spasms and coma.

+ STATEMENT OF PRACTICAL TREATMENT +

Call a doctor (physician), clinic or hospital immediately. Explain that the victim has been exposed to parathion and describe his condition

Move patient immediately from the area where parathion is present

If breathing has stopped, start artificial respiration immediately and maintain until doctor sees victim

If swallowed and victim is awake (conscious) make him vomit quickly. Have victim drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit is clear. Never give anything by mouth to an unconscious person. Have victim lie down and keep quiet. See doctor immediately.

In case of contact, immediately flush eyes or skin with plenty of water while removing contaminated clothing and shoes. See doctor immediately.

NOTE TO PHYSICIAN

Antidote administer atropine sulfate in large doses, TWO to FOUR mg. intravenously or intramuscularly as soon as cyanosis is overcome. Repeat at 5 to 10 minute intervals until signs of atropinization appear. 2-PAM chloride is a pharmacologic antidote and may be administered as an adjunct to, but not a substifute for, atropine which is a symptomatic and often life-saving antidote. DO NOT GIVE MORPHINE OR TRANQUILIZERS. Parathion is a strong cholinesterase inhibitor affecting the central and peripheral nervous systems and producing cardiac and respiratory despression. Affirst sign of pulmonary edema, the patient should be given supplemental oxygen and treated symptomatically. Continued absorption of the poson may occur and fatal relaps have been reported after initial improvement; VERY CLOSE SUPERVISION OF THE PATIENT IS INDICATED FOR AT LEAST 48 HOURS.

ENVIRONMENTAL HAZARDS
