DIRECTIONS FOR USE

Spray infested surface until wet.

ROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily into all cracks, around baseboards and other places where these insects hide. Also behind and beneath cabinets, refrigerators, sinks, stoves, etc. Spray other localized areas infested with these pests. Repeat treatment as required.

CARPET BEETLES: Make localized application to the floor and baseboards. Spray directly into cracks, closets and infested areas of shelvings. Repeat as necessary.

BROWN DOG TICKS: Thoroughly spray infested areas around baseboards, window and duor frames, wall coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. DO NOT TREAT ANIMALS WITH FORMULATION.

FLIES, MOSQUITOES, WASPS AND FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

FLEAS, CHIGGERS, ANTS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas where there is no vegetation, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.
