DIRECTIONS FOR USE

FOR HOUSEFLIES, MOSQUITOES AND GNATS: Close all doors and windows. Point nozzle upward, direct the spray mist to although parts of the room, especially windows and other light sources which attract these insects. Fill the room with west, then leave the treated area. WASPS: Application should be made in late evening when ...
