Wasps: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

FOR CRAWLING INSECTS: Roaches, Earwigs, Grain Mites, Sowbugs, Spiders and Centipedes: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings and around pipes and si s, under refrigerators, baseboards and storage areas. Spray directly on insects where possible. Pepeat as necessary.

Ants: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

STORAGE AND DISPOSAL

Store in a cool, dry area. Do not transport or store below 32°F. Wrap container in several layers of newspaper and discard in trash. Do not incinerate or puncture.
