DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE BEFORE USING

Shake well before each use. Remove protective cap. Aim spray opening away from person. Push button to spray.

Not for use in or around food handling or storage facilities.

For House Flies, Mosquitoes, Gnats, Small Flying Moths: Close all doors and windows. Point nozzle upwards, direct the spray mist to all parts of the room especially windows and other light sources which attract these insects. Fill the room with mist, then leave the treated area. Keep the room closed for at least 15 minutes. Ventilate the room when treatment is completed.

For Wasps, Yellow Jackets And Hornets: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

For Crawling Insects: Cockroaches, Scorpions, Centipedes, Millipedes, Pillbugs, Earwigs, Sowbugs, Spiders: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, baseboards and storage areas. Spray directly on insects when possible. Repeat as necessary.

For Ants: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

To kill Lice and Louse Eggs: Spray in an inconspicuous area to test for possible staining or discoloration. Inspect again after drying, then proceed to spray entire area to be treated.

Hold container upright with nozzle away from you. Depress valve and spray from a distance of 8 to 10 inches.

Spray each square foot for three seconds.

Spray only those garments and parts of bedding, including mattresses, and furniture that cannot be either

laundered or dry cleaned. Allow all sprayed articles to dry thoroughly before use.

Fleas and Ticks: Spray sleeping quarters, bedding, floor and floor covering where pets are kept. Repeat as necessary. Use only a recommended pet spray on pets.

Bedbugs: Spray mattresses, particularly around tufts and seams. Take bedJs apart and spray into all joints. Treat baseboards, moldings and frames. Allow all sprayed articles to dry thoroughly before use. Repeat treatment as necessary.

DISPOSAL

Replace cap, securely wrap container in several layers of newspaper and discard in trash. Do not incinerate.

Harmful if swallowed or absorbed through the skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. Vacate room after treatment and ventilate before reoccupying.
