Submission Dated January 19, 1996

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Delete the statement "Repeat until vomit fluid is clear" from the Statement of Practical Treatment for "IF SWALLOWED".
2. Revise the Statement of Practical Treatment for "IF ON SKIN" to read:

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

3. Revise the Precautionary Statements to read:

"Harmful if swallowed or absorbed through skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling."

Submit five copies of your final printed labeling prior to releasing product for shipment.

A stamped copy of the label is enclosed for your records.
