DIRECTIONS FOR USE

Remove protective cap. Aim spray opening away from ourson. Fush button to spray.

For House Files, Mosquitoes, Small Flying Moths, (Millers) and Gnats: Close all doors and windows, Point nozzle upward, direct the spray mist to all parts of the room, especially windows and other light sources which attract these insects. Fill the room with "mis? then leave the treated areas. Keep the room closed for at least 15 minutes. Ventilate the toom when treatment is completed.
