

DIRECTIONS

Point valve away from face and press actuator button to spray as directed.

IN KENNELS AND SLEEPING QUARTERS: Remove pets, birds and cover fish aquaria before spraying.

Flies, Mosquitoes, Gnats, Wasps, and Flying Moths: Close windows and doors and shut off ventilating systems. Spray at the rate of 2 to 3 seconds per 1000 cubic feet of space, to thoroughly fill the area with mist. Keep room closed 10 to 15 minutes after treatment. Repeat treatment as necessary. Do not remain in treated area and ventilate before reoccupying.

To kill exposed stages of ticks, fleas, lice, cockroaches, spiders, crickets and silverfish: Spray surfaces with special attention to cracks, crevices, and insect hiding places. Spray directly on ticks, roaches, and other insects whenever possible. Remove bedding and spray thoroughly. Repeat treatment as needed.

FOR USE ON DOGS: To kill ticks, fleas, and lice on dogs, spray thoroughly, stroking against the lay of the hair to insure penetration of the fur. Spray directly on ticks.

For temporary protection from the annoyance of mosquitoes, flies, chiggers, and gnats, spray the surface of the hair coat lightly. Repeat treatment as necessary when insects are troublesome.

Not recommended for use on puppies under 4 weeks of age.
