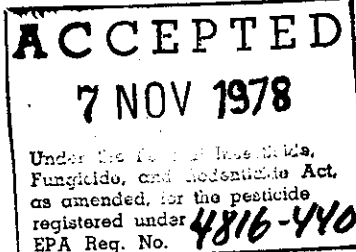

SHAKE BEFORE USING AND AT INTERVALS DURING PRO-
LONGED USE.

Hold container upright with nozzle away from you.
Press valve down and spray as directed. To avoid
possible staining of fabrics or surfaces, do not
spray at close range.

Flies, Mosquitoes, Gnats, Wasps and Flying Moths
(Millers): Close all doors and windows and spray
room at the rate of 1 second per 1000 cubic feet.
Direct spray to all parts of the room, especially
windows and other light sources which attract
these insects. Keep nozzle in constant motion.
Keep room closed for 10 to 15 minutes after treat-
ment. Repeat treatment as necessary.

Roaches, Waterbugs, Silverfish, Crickets, Spiders,
Centipedes and Sow Bugs: Spray into hiding places
such as cracks and crevices, behind sinks, cabi-
nets, along baseboards and floors, around drains
and plumbing, hitting insects with spray whenever
possible. Repeat treatment as necessary.

Ants: Spray trails, nests and points of entry.
Spray on ants where possible. Repeat as necessary.

Indian Meal Moths and Angoumois Grain Moths:
Close doors and windows. Direct spray into all
parts of room especially around stored food pro-
duct containers, pallets and darkened areas.

Spray 7 to 10 seconds for each 1000 cubic feet of
space. Keep area closed for 15 minutes following
treatment. Repeat application weekly or as needed.

Carpet Beetles: Spray directly on beetles, base-
boards, floors, shelves and carpets. Repeat
treatment as necessary.

Confused Flour Beetles, Saw-toothed Grain Beetles,
Granary Weevils, Rice Weevils, Red Flour Beetles,
Grain Mites: Spray into cracks and crevices, pro-
cessing and handling equipment, around cartons or
containers and other areas where these insects
tend to congregate. Spray 30 seconds for each 100
square feet of surface. Keep area closed for 45
minutes to 1 hour after treatment. Repeat appli-
cations as necessary.

Bedbugs: Spray mattresses, particularly around
tufts and seams. Take beds apart and spray into
all joints. Treat baseboards, moldings and floors.
Repeat treatment as necessary.

Fleas: Spray sleeping quarters, bedding, floor
and floor covering where pets are kept. Repeat as
necessary. Use only a recommended pet spray on
pets.
