# DIRECTIONS FOR USE

It is a windation of Federal law to use this product in a manner inconsistent with its labe Ping.

This concentrate is especially recommended for application using mechanical aerosol generating. ULV equipment which produces spray particles in the 5 to 50 micron diameter range with 80% less. than 30 microns. It may be used undiluted or diluted with 50 to 60 second viscosity oil.

#### OUTDOORS

breeze at approximately o miles per hour. Apply from the windward side so the fog will be carried across the area to be treated. Repeat treatment as required.

Using truck-mounted equipment calibrated to deliver 1 ounce per minute, apply undiluted for 3 minute per acre. Diluted with 2 parts concentrate to 1 part oil, apply for 3/4 minute per acre at the same delivery rate. A 300 foot swath may be treated.

#### INDOORS

The use of this product in food processing establishments should be confined to time periods when the plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using.

Remove pets, birds and cover fish aquaria before spraying.

Close doors and windows and shut off ventilating systems. Apply this concentrate undiluted using mechanical aerosol generators. Keep area closed for a minimum of one hour. Vacate treated area and ventilate before reoccupying.

If used in Federally inspected meat or poultry processing plants, dilute with oil at no more than 8.5 fl. oz. to make one gallon (which will result in 5% synergist and 0.5% pyrethrins) and dispense from equipment adjusted to deliver an aerosol spray (no droplets over 50 microns in diameter and 80% less than 30 microns),

To kill adult mosquitoes, fruit flies, and gnats: With generator calibrated to deliver 1 ounce per minute, discharge at a rate of 30 seconds per 1000 cubic feet of space. Repeat treatment when reinfestation occurs.
