DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE BEFORE USE. Point valve away from face and press button. Hold can at least 3 feet from surfaces which may stain.

FLYING INSECTS (Flies, Mosquitoes, Gnats)

Direct spray at insects using short bursts (1 to 2 seconds) or treat unoccupied areas as follows: Close doors and windows. With a sweeping motion, direct spray upward so that the room is filled with mist (8 to 10 seconds per 1000 cubic feet). Keep room closed for 15 minutes and ventilate before reoccupying.

CRAWLING PESTS (Ants, Crickets, and Sowbugs)

Direct spray to contact pests by spraying into cracks of woodwork, walls, floors and other hiding and breeding places.

WASPS AND HORNETS - Direct spray at these insects using short bursts. After insects have settled at night, spray thoroughly into nests, hiding and breeding places.

Avoid breathing of vapor and skin contact. Avoid contact with eyes. In case of contact, flush with water. Do not smoke while spraying.

Do not use in or around animals. Cover or remove fish bowls for one hour.

STORAGE AND DISPOSAL
