Subject: Revised Labeling: Deletion of Commercial Greenhouse Use
Tetralate 2.0-0.44 WB
EPA Registration Number 4816-499
Submission Dated January 19, 1996

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Revise the Precautionary Statements to read:

"CAUTION. Harmful if swallowed. Causes eye irritation. Avoid contact with skin, eyes or clothing. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

2. Revise the Statement of Practical Treatment to read as follows:

IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

IF IN EYES: Flush with plenty of water. Call a physician if irritation persists.

3. Add a Physical and Chemical Hazards Statement that reads:

"Combustible. Do not use or store near heat or open flame."

Submit five copies of your final printed labeling prior to releasing product for shipment.

A stamped copy of the label is enclosed for your records.
