The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below:

1. Revise the Statement of Practical Treatment for IF SWALLOWED to read:

IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting.
Do not give anything by mouth to an unconscious person. Avoid alcohol.

2. Revise the Precautionary Statements to read:

"Harmful if swallowed. Avoid breathing vapor. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling."

3. Add a Physical or Chemical Hazards Statement that reads:

"Combustible. Do not use or store near heat or open flame."

A stamped copy of the label is enclosed. Please submit three copies of revised final printed labeling prior to releasing product for shipment.

The confidential statement of formula (CSF) referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. The CSF for the basic formulation (dated December 16, 1996) has been added to the product file and supersedes all previously-submitted CSF's for the basic formulation.
