DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR PEST CONTROL OPERATOR USE ONLY

This concentrate is designed to be diluted with either water or oil. The dilution rate in water or oil is 2 oz. concentrate in 1 gallon. When diluting with water, prepare only the amount needed for immediate use. Holding a water dilution more than 24 hours is not recommended. Agitate occasionally. For oil dilutions, a deodorized petroleum oil is recommended. Repeat treatment when reinfestation occurs.

To kill:	Ants	Earwigs
	Cockroaches	Spiders
	Crickets	Silverfish

Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry.

To kill Carpet Beetles

Spray edges of carpeting and under carpet and rugs. Make localized application to the floor and baseboards. Spray directly into cracks, crevices, closets and infested areas of shelving. Repeat treatment if reinfestation occurs.

To kill: Flies	Mosquitoes

Use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the homes. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions and in garage where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

To kill. Outdoors: Ants, Chiggers, Fleas

For treatment of localized infestations of these insects in outdoor areas, spray weeds and bushy no-crop areas around the home or buildings thoroughly. Avoid spraying desirable plants. For ants, thoroughly wet hills and runways. Repeat application as infestation occurs.

To kill: Brown dog ticks	Fleas

For rapid cleanout of fleas and brown dog ticks in cellars, animal quarters, kennels where infestation occurs, apply as a surface spray in a good machine adjusted to deliver coarse droplets. Apply to the point of runoff with special attention to cracks and crevices and other insect hiding places. Fresh bedding should be provided

for animals after treatment. Do not treat animals. Repeat treatment as necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE AND PROCEDURES: Store upright at room temperature. Avoid exposure to extreme temperature. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

PESTICIDE DISPOSAL: Pesticide, spray mixture or rinse water that cannot be used according to label instructions must be disposed of at or by an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent) then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved State and local procedures.

CONTAINERS ONE GALLON AND SMALLER: Do not reuse container. Wrap container in several layers of newspaper and discard in trash.
