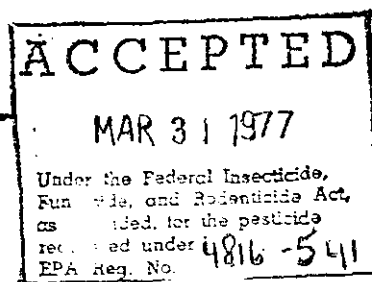

Directions For Use

Spray infested surface until wet.

Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

Remove pets and cover fish bowls before spraying. Do not allow children to contact treated surfaces until surfaces are completely dry.

Roaches, Ants, Silverfish, Spiders, Crickets: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks, crevices, along baseboards, and door sills and frames, behind and beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations. Pests flushed out of hiding should be sprayed directly. Treat ant trails, nests and points of entry. Repeat treatment as necessary.

Carpet Beetles: Spray edges of carpeting and under carpeting and rugs. Make localized application to the floor and baseboards. Spray directly into cracks, closets and infested areas of shelving. Repeat as necessary.

Brown Dog Ticks: Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows and door frames, wall coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. **DO NOT TREAT ANIMALS WITH FORMULATION.**

Flies, Mosquitoes, Wasps, And Small Flying Moths Outdoors: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

Fleas, Chiggers, Ants Outdoors: For treatment of localized infestations of these insects in outdoor areas, spray weeds and bushy non-crop areas around the home thoroughly. Avoid spraying desirable plants. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

Caution: Harmful if swallowed. May be absorbed through the skin. Avoid breathing of spray mist. Avoid contact with skin, eyes or clothing. Wash thoroughly after handling. Do not allow spray to contact food, feedstuffs, or water supplies. Thoroughly wash dishes and food handling utensils if contaminated by this spray.

Environmental Cautions:

This product is toxic to fish, birds, and other wildlife. Keep out of lakes, streams or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.
