SPACE SPRAY: To kill accessible stages of house files, including fruit files, small flying moths, gnats, cheese skippers, and these common stoled product pess: grant@weevits, rices weevits, confused flour beeties, saw-togthed grain beeties, and umoits grain moths, dediterranean flour moths, indian meet moths, explore moths, meet worms and grain mittes: Close windows and doors and shut off ventilating systems. Use a fogger or vaporizor adjusted to deliver an aerosol persy meeting for the step of nurse per 1000 cubic feet at space. In packing and canning plants, use at a rate of 1 ounce to 2000 cubic feet of space.

SPACE AND CONTACT SPRAY: To kill accessible, exposed stages of aliverfish, crickets, roaches, clover mites, cheese mites, earwigs, and anta, first using equipment which can deliver a pin spray, direct spray into all cracks and crevices in woodwork, walls, floors, underneath sinks, behind pipes and in all places where these insects are known to seek shelter. Contact as many insects as possible, spray directly all ant trails. Do not allow spray to contact stored food. Then shutting all doors, windows and shutting off all ventilating systems proceed with space spraying directions as given above. Use a dosage rate of 1 ounce per 1000 cubic feet of space. Vacate and close off treated area. Do not reenter for at least 15 minutes after application. Ventilate before reoccupying. Repeat treatment as necessary.
