General Instructions: This container will dispense premeasured dosages of material. Each push of the actuator button will dispense I teaspoon of concentrate. To make a gallon of finished dilution, push the actuator one time.

Contact spray: For whiteflies, apply at 1 teaspoon per 1 gallon of water (0.6 ml/pint). Spray upper and lower surfaces of plant foliage to point of runoff. Spray in later afternoon and at night only, when the temperature ranges from 50°F to 72°F. Repeat application weekly for four weeks or longer for control of adults and nymphs. Complete spray schedule on pointsettia before blooms form.

Greenhouse Pests: For infestation of whiteflies on begonias, fuschia, salvia, pointsettia, chrysanthemums, coleus, geraniums, ageratum, petunia, aster, calendue, marigold, roses, azaleas, and ivy.
