DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SPACE SPRAY

For rapid control of house flies, fruit flies, mosquitoes, flying moths and gnats: Close doors and windows and shut off ventilating systems. Apply using a good sprayer adjusted to deliver a fine mist. Direct spray toward upper portions of the enclosure filling the room with mist. Use 1/2 to 1 ounce per 1000 cubic feet of space.

To kill exposed stages of cockroaches, ants, spiders, clover mites, cheese mites, confused flour beetles, sawtoothed grain beetles, red flour beetles, rice weevils, granary weevils and grain mites: Treat as above using 2 to 3 ounces per 1000 cubic feet of space. Keep area closed for at least 15 minutes. Vacate treated area and ventilate before reoccupying. Repeat treatment when reinfestation occurs.

SURFACE SPRAY

To insure maximum control of the crawling insects named above, apply as a coarse mist directed toward insects, into cracks and crevices, along baseboards, around the base of machinery, containers of stored products and other areas where insects may hide. Spray ant trails, nests and points of entry. Spray badly infested areas daily. In other areas, repeat treatment twice weekly or when reinfestation occurs.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal

PESTICIDE STORAGE AND SPILL PROCEDURES: Store upright at room temperature. Avoid exposure to extreme temperatures. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

PESTICIDE DISPOSAL: Pesticide, spray mixture or rinse water that cannot be used according to label instructions may be disposed of at or by an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent) then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved State and local procedures.

CONTAINERS ONE GALLON AND SMALLER: Do not reuse container. Wrap container on several layers of newspaper and discard in trash.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Contact a physician or Poison Control Center immediately. Do not induce vomiting unless directed by a physician. Vomiting may cause aspiration pneumonia.

If Inhaled: Remove affected person to fresh air. Apply artificial respiration if indicated.

If In Eyes: Flush with plenty of water. Contact a physician if irritation persists.

If on Skin: Remove contaminated clothing and wash affected areas of skin with soap and water.
