Close windows and doors and shut off ventilating systems. Apply with a good machine adjusted to deliver a fine mist or fog. In Official Heat and Poultry Establishments use a fogger or vaporizor adjusted to deliver an aerosol spray (no droplets over 50 microns in diameter and 80% less than 30 microns). Apply at the rate of 1 ounce per 1000 cubic fact of space. Direct the spray toward the ceiling and upper corners of the area and behind obstructions. Keep the area closed for at least 15 minutes. Vacate the treated area and ventilate before reoccupying. Repeat treatment as necessary. In other than Official

Meat and Poultry Establishments a combination of apot surface treatment and fugging is recommended.

SURFACE SPRAYING: To control roaches, ants, silverfish, spiders, crickets, clover mites, cheese mites, granary weevils, rice weevils, confused flour beerles, runt red flour beetles, sautoothed grain beetles, spider beetles, cigarette beetles, drugstore beetles, meal worms, grain mites, and cadelles: Use a good sprayer adjunted to deliver a coarse wet spray. Direct the spray into hiding places, cracks and crevices, under pallets, around containers of stored foods, around the base of machinery, behind shelves and drawers. For silverfish, spray bookcases. For ants, spray trails, nests and points of entry. If surface application only is to be used, spray floors, walls, and other surfaces at a rate of 1 gallon to 750 square feet of surface.

To control carpet beetles: Spray edges of carpeting and under carpeting and tugs and infested clothing and furniture. Make a localized application to floor and baseboards. Spray directly into cracks, closets, and infested areas of shelving. Repeat treatment as necessary.

To control bedbugs: Spray mattresses lightly, particularly around tufts and meams. Take bads apart and spray in all joints. Treat baseboards, moldings, and floors. Repeat treatment as needed.

To control fleas and brown dog ticks: Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards smolelings, windsw and door frames, and bocalized transport floor and floor coverings Fresh hedding should be blaced in animal quarters following treatment? Concurrent treatment of animals with an approved insecticide is recommended. Repeat treatment as needed.

To control clothes moths: Remove any infested articles from standing brush theoroughly and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus, and other storage containers, directing the spray into cracks, joints, and crevices. After airing, infested articles may be treated lightly, keeping the spray nozzle at least three feet from the fabric to avoid staining. Store clotness in moth tight containers or repeat treatments wonthly. In House Barns and on Borses
