DIRECTIONS FOR USE

This ready-to-use concentrate may be dispersed through good mechanical, thermal, or compressed air fogging or spraying equipment.

SPACETREATMENT: Close doors and windows and shut off ventilating systems. Apply as a fog or fine mist, distributing the spray throughout the area. Use at a rate of 1 ounce per 1000 cubic feet of space. Direct spray behind and under obstructions and contact crawling insects whenever possible. Keep area closed for 10 to 15 minutes. Vacate treated area and ventilate before reoccupying. Repeat treatment as necessary.
