Subject: Amendment- Revise per Diazinon Registration Standard
Pyrenone Diazinon Aqueous Base
EPA Registration Number 4816-621
Your submission dated October 15, 1993

This amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable, provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Delete the use site sections "TERRESTRIAL FOOD CROPS", "INSIDE: mushroom houses", "TERRESTRIAL NON-CROP AREAS INCLUDING", and "ANIMALS".
 - b. Replace the **PRECAUTIONARY STATEMENTS** section with "Harmful if swallowed, inhaled, or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling and before smoking or eating. Remove contaminated clothing and wash before reuse. Avoid contamination of food and feed."
 - c. Replace the **STATEMENT OF PRACTICAL TREATMENT** section with:
IF SWALLOWED: Drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit is clear. Call a physician or Poison

Control Center immediately. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

IF INHALED: Remove victim to fresh air and apply artificial respiration if indicated. Get medical attention.

IF ON SKIN: Remove contaminated clothing and wash affected areas promptly with soap and water. Get medical attention.

IF IN EYES: Rinse eyes with plenty of water and call a physician immediately.

Note to Physician: This product is an organophosphate, insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine. This product contains a petroleum distillate solvent, which may present an aspiration hazard. Gastric lavage may be indicated if product was taken internally.

- d. In the first sentence of the **Environmental Hazards**, change "This Product" to "This product".
3. Submit three (3) copies of your final printed labeling before you release the product for shipment. This product is subject to the released for shipment and channels of trade deadlines stipulated in the Diazinon Registration Standard, as amended.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

Your current Confidential Statement of Formula (CSF), does not list the impurities of toxicological concern separately, nor does it include the certification for FIFRA Sec. 12(a)(1)(C), or the certification regarding the determination of the certified limits for the toxicologically significant impurities, i.e., reliance on Ciba-Geigy's analysis of their technical. Please check with your supplier in this regard and update your CSF accordingly within 75 days.
