PRECAUTIONARY STATEMENTS

Hazards To Humans & Domestic Animals

CAUTION

Harmful if absorbed through the skin. Avoid contact with eyes. In case of contact, immediately flush eyes with plenty of water. Get medical attention if irritation persists. Keep away from food, feedstuffs and domestic water supplies. Wash thoroughly after handling. Do not allow children or pets to contact treated surfaces until spray has dried.

Do not spray air in rooms or use on plants. Apply as a surface spray only as specified on this label.

Do not allow spray to contact food, feedstuffs or water supplies. Thoroughly wash dishes and food handling utensils if contaminated with this product.

Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in eating areas while food is exposed.

Remove pets and cover tubs before spraying.

Environmental Hazards

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **Pesticide Storage And Spill Procedures:** Store upright at room temperature. Avoid exposure to extreme temperatures. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, Fuller's earth, etc. Dispose of with chemical waste.

Pesticide Disposal: Pesticide, spray mixture or rinse water that cannot be used according to label instructions must be disposed of at or by an approved waste disposal facility.

Container Disposal: Triple rinse (or equivalent) then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved State and local procedures. **Containers One Gallon and Smaller:** Do not reuse container. Wrap container in several layers of newspaper and discard in trash.

SHAKE WELL BEFORE USING

TO CONTROL: *Ants, Boxelder bugs, Centipedes, Cockroaches, Crickets, Earwigs, Palmetto bugs, Pillbugs, Scorpions, Silverfish, Spiders, Spider beetles and Waterbugs:* Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevices, along baseboards, door sills and frames, behind and beneath sinks, stoves, refrigerators, cabinets, and around garbage cans, plumbing and other utility installations. Pests flushed out of hiding should be sprayed directly.

ANTS: Treat ant trails, nests and points of entry. Repeat treatment as necessary.

AQUEOUS RESIDUAL SPRAY

TO CONTROL BROWN DOG TICKS: Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows and door frames, wall and floor coverings where localized areas of infestation occur. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. DO NOT TREAT ANIMALS WITH THIS FORMULATION.

TO CONTROL: *Carpet Beetles, Cigarette Beetles, Clothes Moths*: Spray edges of carpeting and under carpeting, rugs and closets. Make localized application to the floor and baseboards. Spray directly into cracks, crevices, closets and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

TO CONTROL: *Fruit flies, Gnats, House Flies, Mosquitoes, Small Flying Moths*: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures or porches, in garages and other places where these insects alight or congregate.

TO KILL: *Fleas and Brown Dog Ticks*, thoroughly apply as a spot treatment to infested areas such as pet's beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet areas. DO NOT TREAT PETS WITH THIS PRODUCT. Treat pets with a product registered for animal application to control the source of flea and tick infestation.
