- (1) Add the following language to the PRECAUTIONARY STATEMENTS section of the respective product labels: Causes substantial but temporary eye damage. Do not get in eyes or on clothing. Wash thoroughly with soap and water after use.
- (2) Add the following language to the STATEMENT OF PRACTICAL TREATMENT: IF SWALLOWED section of the respective product labers: Drink promptly a large quantity of milk, egg white, gelatin solution, or, if these are not available, large quantities of water. Avoid alcohol.


