Keep room closed for 15 minutes. Ventilate room before reentering. Repeat as necessary.

#### TO KILL FLYING INSECTS

HOUSEFLIES, STABLEFLIES, MOSQUITOES, SMALL FLYING MOTHS, GNATS: There is no need to spray directly at flying insects. Spray up into the air with a sweeping motion. Keeping about 3 feet from interior walls, fabric and furniture until room is filled with mist. Keep closed for 15 minutes. Ventilate room before entering. Pepeat as necessary.

WASPS & HORNETS: Spray directly on stray wasps and hornets that enter building.
