



An outdoor product for use in backyards, patios, picnic areas. Sprays out far beyond ordinary insect sprays—actually kills bugs up to 20 feet away. Exclusive jungle-tested formula kills and repels flies, mosquitoes, gnats and ants. Also kills flying moths, wasps and hornets.

CHILD GUARD CAP To SPRAY, remove tamper-proof tab on front of spray cap. Look into hole on top of cap and turn cap until white mark appears. To LOCK, turn cap until white mark disappears.

DIRECTIONS: SHAKE BEFORE USING

Point spray nozzle away from face. Hold can on slight downward angle. For best results spray when air is calm. Allow a few minutes for product to take effect.

FLYING INSECTS: Flies, mosquitoes, gnats. Allow fog to drift over area. Direct spray toward bushes or grass from at least 4 to 6 feet away. Give special attention to breeding areas, such as garbage cans, compost piles. Repeat if necessary. Spray hornet and wasp nests at night when they are less active.

CRAWLING INSECTS: Ants, crickets, centipedes. Spray infested surface of patio or picnic area, hitting as many insects as possible. Also spray legs of tables and chairs to repel ants. Spray ant hills for best control.


DISPOSAL: Do not reuse empty container. Wrap container and put in trash collection.

CAUTION

Do not smoke while spraying. Avoid inhalation. Do not spray toward face or on pets. Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 120°F may cause bursting. Not for indoor use. Cover exposed food. Do not spray on food crops or contaminate fish ponds. Keep 4 to 6 feet away from ornamental plants while spraying.

ACTIVE INGREDIENTS: Pyrethrins, 0.20%, technical piperonyl butoxide, 1.00% (equivalent to 0.8% of (butylcarbityl) (6-propylpiperonyl) ether and 0.2% related compounds), technical Methoxychlor, 1.00% (equivalent to 0.9% 2,2-bis (p-methoxyphenyl) -1,1,1-trichloroethane and 0.1% other isomers and reaction products), 2-hydroxyethyl n-octyl sulfide, 0.95%, (and related compounds), 0.05%, Petroleum Distillate 0.80%.
