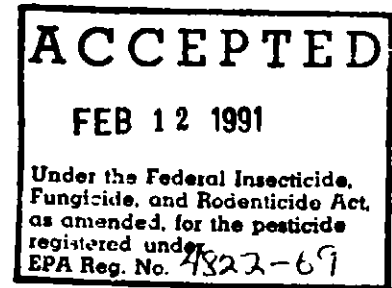

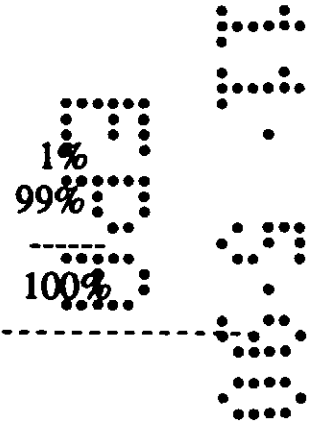

In addition to rapid kill, the residue on treated surfaces continues to kill insects for weeks after the residue has dried.

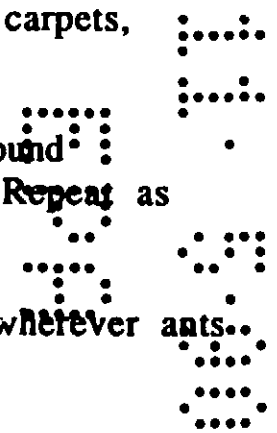
DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Non-food Areas - such as garbage rooms, lavatories, floor drains, vestibules, entries, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and finished goods storage areas. Not for use on plants. Do not spray up into air. Apply as a wet (coarse) spray toward cracks, crevices, along baseboards, doors and windowsills. Spray in inaccessible areas behind stoves, refrigerators and around garbage cans. Hold container about 12" from the surface being treated. Spray until wet. Avoid excessive wetting of asphalt, tile, rubber and plastic. Do not spray open floor areas, carpets, furniture, beds or bedding.

ROACHES, WATERBUGS: Spray into cracks, crevices, around baseboards and other places where these insects hide. Repeat as necessary.

ANTS: Apply to ant trails, around door and windows wherever ants may enter. Repeat as necessary.



SILVERFISH, CRICKETS, EARWIGS, MILLIPEDES, SCORPIONS, SOWBUGS, SPIDERS, SAW-TOOTHED GRAIN BEETLES: Spray infested areas as recommended under directions for use. Repeat as necessary.

FLIES AND MOSQUITOES: For use outdoors only: As an aid in reducing annoyance from these insects, spray outside surfaces of screens, doors, window frames, or wherever these insects may enter. Also treat other places where these insects may alight or congregate.

Pest control in food handling areas of meat packing and food processing plants where exposed food is held, processed or served.

"Crack and crevice" treatment only." - Apply in small amounts in a pin-thin stream directly into cracks and crevices between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where insects hide. Do not use this product in conduits, motor housings or electrical switch boxes.

Controls cockroaches, crickets, earwigs, silverfish, waterbugs, millipedes, sowbugs, spiders. Aids in the control of saw-toothed grain beetles.

APPLICATIONS OF THIS PRODUCT IN AREAS WHERE FOOD IS HELD, PROCESSED OR SERVED, OTHER THAN AS A CRACK AND CREVICE TREATMENT, IS NOT PERMITTED.

Spraying unloading docks and outside areas where insects congregate will aid in preventing re-infestations. Good sanitation and proper disposal of wastes is essential in any effective insect control program.
